- 5 that we are doing our best.
- 6 As far as our phone system is, I have put in an ask
- 7 to upgrade our phone system. I assume we're going to go through
- 8 with that. I want to be able to capture everyone's messages so
- 9 that we can put everyone in queue so people are not waiting for
- 10 a long time, but it's not a Maryland Board of Nursing decision,
- 11 it would be Downtown. So, I am searching out to see if we can
- 12 upgrade our phone system to help out our constituents so that
- 13 they can have better access to the Board.
- So, those are my two things that I have for this
- 15 morning.
- 16 MR. HICKS: Thank you, Karen. And I would just
- 17 remind everyone that this is no different than what many of the
- 18 hospitals are facing across the country as well as different
- 19 organizations and companies in terms of, you know, employment
- 20 challenges that's everyone's facing. So, again, to reiterate
- 21 what Karen said, please be patient. We will get you done as

- 1 quickly as we possibly can, so.

- 2 MS. GREEN: Thank you. Good morning, everyone. The
- 3 first item on our agenda is Item 4A. This is a follow-up in
- 4 terms of what has been introduced to the Practice and Education
- 5 Committee in May. This is an FYI to the Board regarding
- 6 Allegany College of Maryland's Certified Medical Assistant
- 7 Pathway to Nursing, i.e., LPN or RN route.
- 8 We have received a request from another college to
- 9 look at this not to look at, but to verify whether or not
- 10 there was a certified medical assistant program that would take
- 11 us through to become a nurse. In the review of what Allegany
- 12 College of Maryland actually provided, this is not a program,
- 13 this is only a pathway. It is an internal decision made by the
- 14 Curriculum Committee of Allegany College of Maryland. It has
- 15 not changed anything related to the established and traditional
- 16 LPN and RN programs at Allegany College that have been approved
- 17 by both the Maryland Higher Education Commission as well as the
- 18 Board of Nursing. What Allegany College is offering is the
- 19 opportunity for individuals who have met the certified medical
- 20 assistant requirements through the college, because they have
- 21 an established program for the CNA. It gives an opportunity to

- 1 look at a pathway should they choose want to continue in
- 2 nursing once they have been also nationally certified.
- 3 So, our findings in this review are just to make
- 4 sure there was clarity and to provide to the Board the
- 5 documents, their catalog regarding how the medical assistant
- 6 program is set up, as well as the LPN and RN and associate
- 7 degree program that now the Board of Nursing has approved their
- 8 CMA training program, their certified nursing medicine aide
- 9 program. The CMA nursing pathway prerequisite, and course
- 10 requirements, should a person choose to use this pathway to the
- 11 LPN/RN programs. We also looked at a course that was a major
- 12 piece to the pathway that has been established at Allegany
- 13 College, it is Nursing 177. It's an introduction of the CMA to
- 14 nursing. It includes the nursing process issues related to
- 15 nursing, what is nursing about to give them a segue in. They
- 16 must meet all prerequisite requirements as anyone else entering
- 17 the LPN or RN program at Allegany College of Maryland.
- 18 You also have in your packet email discussions with
- 19 Mr. Rick "Paul" Cooper, who is the associate dean of the nursing
- 20 program and program administrator; and Dr. William Rock, who's
- 21 the dean of career education. As mentioned, this is merely a

- 1 pathway. It was approved by the Internal Curriculum Committee.
- 2 This does not have any impact on the requirements or standards
- 3 that are already established for any student entering the LPN or
- 4 RN program. The applicant can choose to move from being a CMA
- 5 to becoming enrolled in the LPN or RN program, meeting all
- 6 admission criteria for the LPN or RN programs.
- 7 The recommendations were presented to the Practice
- 8 and Education Committee on June the 10th and accepted. And our
- 9 recommendation to the Maryland Board of Nursing is only as an
- 10 FYI to accept Board Staff findings that the CMA to nursing is a
- 11 pathway to enter into LPN or RN programs of study at Allegany
- 12 College of Maryland, that the LPN and RN programs offer, that
- 13 ACM has approval from the Maryland Higher Education Commission
- 14 and the Board of Nursing, and that the LPN and RN programs
- 15 continue to meet COMAR 10.27.03, Nursing Education Programs.
- This is offered to the Board only as an FYI. There
- 17 are no issues or circumstances, it is merely a pathway that a
- 18 person can consider once they successfully complete the
- 19 certified medical assistant program. And I will answer any
- 20 questions you may have.
- 21 I also need to inquire if Mrs. Clark or Dr. Yokum

1 are on the line this morning, as well as Dr. Rock - William

- 2 Rock from ACM.
- 3 (No responses)
- 4 MS. GREEN: Okay.
- 5 MR. HICKS: Are there any questions for Dr. Green?
- 6 (No questions posed)
- 7 MR. HICKS: All right. For the record, I just want
- 8 to make everyone's aware that Damare Vickers is online. So,

- 10 MS. VICKERS: Good morning. Damare is here.
- 11 MR. HICKS: Good morning, Damare.
- 12 MS. VICKERS: Good morning.
- MR. HICKS: All right, Dr. Green, you can go on.

- MR. HICKS: Yes, good morning.

- 21 MS. GREEN: 4B is change of administrator for

- 1 Stevenson University. This is for Dr. Jamie Carter.
- 2 Dr. Feustle Dr. Judy Feustle who has now formally
- 3 retired from Stevenson University as of June the 10th, who
- 4 served as interim department chair and associate dean and chief
- 5 administrator since January, 2022 following the resignation and
- 6 departure of Dr. Laura Petri. She was recognized as the
- 7 Board-approved nursing program administrator for Stevenson
- 8 University.
- 9 On June the 1st of 2022, Dr. Jamie Carter joined
- 10 Stevenson University full-time as the department chair for
- 11 nursing. Dr. Carter is responsible for the administration of
- 12 all aspects of the undergraduate program and the pre-licensure
- 13 of RN to BS, as well as the associate to bachelor program
- 14 option, and she has a direct reporting responsibility to Dr.
- 15 Meredith Durmowicz, who is the dean of Fine schools of the
- 16 Sciences of Stevenson University.
- 17 Dr. Carter has fifteen years of experience as a
- 18 registered nurse, and its inclusive of emergency trauma nursing,
- 19 nursing education by way of example. She completed her
- 20 pre-licensure and graduate nursing education at the University
- 21 of Maryland School of Nursing in the clinical nurse leader MSN

- 1 program, nurse practitioner, clinical nurse specialist program,
- 2 and her doctorate in nursing practice from that program. She
- 3 holds a current Maryland multistate nursing license. She is
- 4 professionally and experientially qualified to serve as the
- 5 Board recognized nursing program administrator for the
- 6 undergraduate nursing education program at Stevenson University
- 7 in accordance our COMAR 10.27.03.07.
- 8 The recommendations were accepted by the Practice
- 9 and Education Committee on June 10th. And our request today and
- 10 recommendation to the Board is to accept the Practice and
- 11 Education Committee recommendation for approval, and to approve
- 12 Dr. Jamie Carter as the Board recognized nursing program
- 13 administrator for the Stevenson University undergraduate nursing
- 14 education program.
- 15 I would just like to make a special note to the
- 16 Board that next month we will present Dr. Vanessa Velez, who is
- 17 also going to be identified as a nursing program administrator
- 18 for the graduate program at Stevenson University. It's just a
- 19 timing of when her actual information was submitted, but we
- 20 request respectfully that right now we approve Dr. Jamie Carter.
- 21 MR. HICKS: All right.

- 7 4C, Notre Dame of Maryland University Nurse
- 8 Practitioner Masters of Science Nursing Programs: Adult
- 9 Gerontology Primary Care and Family Nurse Practitioner. As I
- 10 mentioned last month with the review of the onsite site visit
- 11 that we concluded and presented to the Board, this packet is
- 12 coming forward. The program has been approved by the Maryland
- 13 Higher Education Commission to offer the masters of science of
- 14 nursing degree in these two areas of study for the nurse
- 15 practitioner, adult gerontology primary care and family nurse
- 16 practitioner. They plan to begin in the Fall of 2022.
- 17 The findings were that the nurse practitioner
- 18 program information met all requirements for COMAR
- 19 10.27.07.06(b) 1 through 6 and (c)1 as it relates to our
- 20 regulatory requirements.
- 21 The recommendations were accepted by the Practice

- 1 and Education Committee on June 10, 2022. And our request to
- 2 the Board is to accept the recommendation from the Practice and
- 3 Education, and to approve the proposed advanced practice nursing
- 4 education program submitted by Notre Dame of Maryland University
- 5 to begin in the Fall of 2022.
- 6 You have in your attachment information, Attachment
- 7 A, the adult gerontology primary care program with all the
- 8 approvals, as well as in Attachment B, the information for the
- 9 family nurse practitioner program, and the description of the
- 10 courses.
- I will entertain any questions that you may have
- 12 regarding this program. Thank you.
- MS. WISSER: Dr. Green, this is Kathy Wisser. I am
- 14 on the line. I just needed to unmute myself.
- 15 MS. GREEN: Sure. Thank you, Dr. Wisser, and we're
- 16 glad to have you here.
- MS. WISSER: Thank you.
- MR. HICKS: So, we will approve both of those
- 19 programs separately.

- 8 letter from Karen Ms. Evans to send it to final processing so
- 9 we can move forward with the program. Thank you so much.
- 10 MS. WISSER: Thank you.
- MR. HICKS: Dr. Green, before you go onto 4D, I just
- 12 want to acknowledge that Charlene
- 13 Harrod-Owuamana is on the line. So, if we can reflect that on
- 14 the record of attendance.
- Moving forward, 4D, Dr. Green.
- MS. GREEN: Thank you. This is also an FYI to the
- 17 Board. This is regarding the University of Maryland. They have
- 18 submitted a substantial modification for the bachelor of science
- 19 degree in nursing education program to the Maryland Higher
- 20 Education Committee, and the Board received information to the
- 21 effect that if there were any questions or concerns that may be

- 1 necessary from this submission from the University of Maryland
- 2 that they need to become forth in doing so. All individuals
- 3 were given until June 15, 2022.
- 4 We have not heard, but I would anticipate barring
- 5 any complications, that the University of Maryland will receive
- 6 a letter of approval from Maryland Higher Education Commission.
- 7 Dr. Howard, are you on the line?
- 8 MS. HOWARD: I am, indeed. Thank you, Dr. Green.
- 9 MS. GREEN: So glad to have you. Thank you so much.
- 10 Dr. Howard has the undergraduates, the baccalaureate program
- 11 for the University of Maryland.
- MS. HOWARD: My colleague, Dr. Mech, is also on the
- 13 line.
- MR. MECH: Hi. I'm the director of legal affairs.
- MS. GREEN: Hi, Dr. Mech. It's good to have you as
- 16 well.
- Our findings for the the proposal is designed to
- 18 address the substantial modification changes that were
- 19 promulgated by the American Association of Colleges of Nursing,
- 20 also known as AACN.
- 21 There are two things with the standards and the

- 1 essentials with the core competency for professional nursing for
- 2 the BSN nursing education program. The information included in
- 3 the proposal in front of you, which is effective now by the new
- 4 program of study for the entry level to the BSN program. The
- 5 curriculum will be organized in the context of the AACN's, which
- 6 include wellness, health, and the prevention in disease
- 7 management, degeneration and restorative care, special
- 8 population, and transmission to practice in leadership. For the
- 9 Board's information, the BSN curriculum remained credit neutral
- 10 with 120 credits. The course descriptions are included and they
- 11 meet the COMAR 10.27.03.13 under Curriculum Requirements, and
- 12 the general education requirements are included and specify the
- 13 professional standards for the program. This information was
- 14 reviewed by the Practice and Education Committee and approved
- 15 June 10th of 2022.
- Our recommendation today is that it's really,
- 17 first of all, depending upon the final approval authorized by
- 18 the Maryland Higher Education Commission and as MHEC approval
- 19 that the UBM staff will request that the Board accept the
- 20 recommendation from the Practice and Education Committee to
- 21 approve the University of Maryland baccalaureate curriculum

- 1 substantial modification in accordance with COMAR 10.27.03.13,
- 2 and will provide a follow-up the staff will provide a
- 3 follow-up summary to the Board.
- 4 The information included in the packet is the
- 5 information that we need to move through the Higher Education
- 6 Commission, the appendix on entry-level new program of study and
- 7 course description as well as the general ed content information
- 8 that are also required in all of our programs.
- 9 I will entertain any questions that you may have,
- 10 and this is also just an FYI to the Board at this time.
- 11 MR. HICKS: Thank you, Dr. Green. Are there any
- 12 questions for Dr. Green or the faculty for the University of
- 13 Maryland School of Nursing?
- 14 (No questions posed)
- MR. HICKS: All right. Moving on to 4E, Dr. Green.
- MS. GREEN: Thank you, Dr. Howard and Dr. Mech for
- 17 joining us today. We appreciate you.
- 18 MS. HOWARD: Thank you, Dr. Green.
- 19 MS. MECH: Thank you.
- MS. GREEN: All right, 4E, this is a program, Brown
- 21 Mackie College formerly located in Miramar, Florida is a closed

- 1 associate degree program. It is not substantially equivalent.
- 2 We were asked to assess this program to determine substantial
- 3 equivalency, and our findings were that the we have email
- 4 correspondence from Dr. Sherri Sutton-Johnson regarding the
- 5 closure of the program, and the fact that it has not achieved
- 6 NCLEX requirements in order to continue as an approved program.
- 7 Historical public information is included in this
- 8 packet. There was some legal issues regarding the operation of
- 9 this program that were discovered during the review. This was a
- 10 private for-profit college system all over The United States,
- 11 and there was some major concerns about fraudulent advertising
- 12 and recruitment of students in the program that are included in
- 13 the document that you have. Then also, the third bullet
- 14 indicates the Department of Justice notice
- 15 for-profit college companies and the settlement of consumer
- 16 fraud that they had been identified with (indiscernible)
- 17 recognition of accrediting agencies of which Brown Mackie
- 18 College was a member.
- 19 We presented to the Practice and Education Committee
- 20 on June 10th of 2022, and they accepted our findings and
- 21 determination that this program is not substantially equivalent,

- 7 certified nursing assistant except under certain circumstances.
- 8 Alters the composition of the Certified Nursing Assistant
- 9 Advisory Committee. And finally, this bill authorizes the
- 10 Board to conduct site visits of certified dialysis technician
- 11 training programs.
- 12 The Board submitted a Letter of Support with
- 13 Amendments.
- House Bill 219, cross-filed with Senate Bill 306:
- 15 Dental Hygienists Consultation Requirements Health Care
- 16 Practitioners. This bill alters the types of health care
- 17 practitioners a dental hygienist must consult with before
- 18 providing certain treatment to a dental patient. It requires
- 19 that a dental hygienist consult with a practitioner if there is
- 20 a change in the patient's medical condition.
- 21 The Board took no position.

- 17 Healthcare Workforce Expansion. The bill establishes
- 18 requirements for the Board related to the expansion of the

- 8 MR. HICKS: All right. Any questions for Dr.
- 9 Forbes-Scott?
- 10 (No questions posed)
- 11 MR. HICKS: All right. Thank you, Dr. Forbes-Scott
- 12 for stepping in and doing a great job.
- MS. FORBES-SCOTT: Thank you.
- 14 MS. EVANS: Gary, can we hold Dr.
- 15 Forbes-Scott for a second, please?
- 16 MR. HICKS: Sure.
- 17 MS. EVANS: Thank you. I just want to say to
- 18 everyone publicly that Dr. Forbes-Scott is moving on. However,
- 19 what I wanted to say is that she has been such a joy and a
- 20 pleasure and has been such a creative, magnifying, really turned
- 21 the Education Department around, and I just want us to send her

- 1 off correctly. And I just wanted to say publicly, Dr.
- 2 Forbes-Scott, I appreciate all of your hard work and we're going
- 3 to miss you, but I just want to thank you for what she's done
- 4 for the Board.
- 5 MS. FORBES-SCOTT: Thank you very much, Ms. Evans.
- 6 It's been a pleasure, and thank you all for allowing me to
- 7 serve.

- 10 and Practice Committee.

- 3 first item on our agenda is Item 4A. This is a follow-up in
- 4 terms of what has been introduced to the Practice and Education
- 5 Committee in May. This is an FYI to the Board regarding
- 6 Allegany College of Maryland's Certified Medical Assistant
- 7 Pathway to Nursing, i.e., LPN or RN route.
- 8 We have received a request from another college to
- 9 look at this not to look at, but to verify whether or not
- 10 there was a certified medical assistant program that would take
- 11 us through to become a nurse. In the review of what Allegany
- 12 College of Maryland actually provided, this is not a program,
- 13 this is only a pathway. It is an internal decision made by the
- 14 Curriculum Committee of Allegany College of Maryland. It has
- 15 not changed anything related to the established and traditional
- 16 LPN and RN programs at Allegany College that have been approved
- 17 by both the Maryland Higher Education Commission as well as the
- 18 Board of Nursing. What Allegany College is offering is the
- 19 opportunity for individuals who have met the certified medical
- 20 assistant requirements through the college, because they have
- 21 an established program for the CNA. It gives an opportunity to

- 1 look at a pathway should they choose want to continue in
- 2 nursing once they have been also nationally certified.
- 3 So, our findings in this review are just to make
- 4 sure there was clarity and to provide to the Board the
- 5 documents, their catalog regarding how the medical assistant
- 6 program is set up, as well as the LPN and RN and associate
- 7 degree program that now the Board of Nursing has approved their
- 8 CMA training program, their certified nursing medicine aide
- 9 program. The CMA nursing pathway prerequisite, and course
- 10 requirements, should a person choose to use this pathway to the
- 11 LPN/RN programs. We also looked at a course that was a major
- 12 piece to the pathway that has been established at Allegany
- 13 College, it is Nursing 177. It's an introduction of the CMA to
- 14 nursing. It includes the nursing process issues related to
- 15 nursing, what is nursing about to give them a segue in. They
- 16 must meet all prerequisite requirements as anyone else entering
- 17 the LPN or RN program at Allegany College of Maryland.
- 18 You also have in your packet email discussions with
- 19 Mr. Rick "Paul" Cooper, who is the associate dean of the nursing
- 20 program and program administrator; and Dr. William Rock, who's
- 21 the dean of career education. As mentioned, this is merely a

- 1 pathway. It was approved by the Internal Curriculum Committee.
- 2 This does not have any impact on the requirements or standards
- 3 that are already established for any student entering the LPN or
- 4 RN program. The applicant can choose to move from being a CMA
- 5 to becoming enrolled in the LPN or RN program, meeting all
- 6 admission criteria for the LPN or RN programs.
- 7 The recommendations were presented to the Practice
- 8 and Education Committee on June the 10th and accepted. And our
- 9 recommendation to the Maryland Board of Nursing is only as an
- 10 FYI to accept Board Staff findings that the CMA to nursing is a
- 11 pathway to enter into LPN or RN programs of study at Allegany
- 12 College of Maryland, that the LPN and RN programs offer, that
- 13 ACM has approval from the Maryland Higher Education Commission
- 14 and the Board of Nursing, and that the LPN and RN programs
- 15 continue to meet COMAR 10.27.03, Nursing Education Programs.
- This is offered to the Board only as an FYI. There
- 17 are no issues or circumstances, it is merely a pathway that a
- 18 person can consider once they successfully complete the
- 19 certified medical assistant program. And I will answer any
- 20 questions you may have.
- 21 I also need to inquire if Mrs. Clark or Dr. Yokum

1 are on the line this morning, as well as Dr. Rock - William

- 2 Rock from ACM.

- 7 Board-approved nursing program administrator for Stevenson
- 8 University.
- 9 On June the 1st of 2022, Dr. Jamie Carter joined
- 10 Stevenson University full-time as the department chair for
- 11 nursing. Dr. Carter is responsible for the administration of
- 12 all aspects of the undergraduate program and the pre-licensure
- 13 of RN to BS, as well as the associate to bachelor program
- 14 option, and she has a direct reporting responsibility to Dr.
- 15 Meredith Durmowicz, who is the dean of Fine schools of the
- 16 Sciences of Stevenson University.
- 17 Dr. Carter has fifteen years of experience as a
- 18 registered nurse, and its inclusive of emergency trauma nursing,
- 19 nursing education by way of example. She completed her
- 20 pre-licensure and graduate nursing education at the University
- 21 of Maryland School of Nursing in the clinical nurse leader MSN

- 1 program, nurse practitioner, clinical nurse specialist program,
- 2 and her doctorate in nursing practice from that program. She
- 3 holds a current Maryland multistate nursing license. She is
- 4 professionally and experientially qualified to serve as the
- 5 Board recognized nursing program administrator for the
- 6 undergraduate nursing education program at Stevenson University
- 7 in accordance our COMAR 10.27.03.07.
- 8 The recommendations were accepted by the Practice
- 9 and Education Committee on June 10th. And our request today and
- 10 recommendation to the Board is to accept the Practice and
- 11 Education Committee recommendation for approval, and to approve
- 12 Dr. Jamie Carter as the Board recognized nursing program
- 13 administrator for the Stevenson University undergraduate nursing
- 14 education program.
- 15 I would just like to make a special note to the
- 16 Board that next month we will present Dr. Vanessa Velez, who is
- 17 also going to be identified as a nursing program administrator
- 18 for the graduate program at Stevenson University. It's just a
- 19 timing of when her actual information was submitted, but we
- 20 request respectfully that right now we approve Dr. Jamie Carter.

- 12 coming forward. The program has been approved by the Maryland
- 13 Higher Education Commission to offer the masters of science of
- 14 nursing degree in these two areas of study for the nurse
- 15 practitioner, adult gerontology primary care and family nurse
- 16 practitioner. They plan to begin in the Fall of 2022.
- 17 The findings were that the nurse practitioner
- 18 program information met all requirements for COMAR
- 19 10.27.07.06(b) 1 through 6 and (c)1 as it relates to our
- 20 regulatory requirements.
- 21 The recommendations were accepted by the Practice

- 1 and Education Committee on June 10, 2022. And our request to
- 2 the Board is to accept the recommendation from the Practice and
- 3 Education, and to approve the proposed advanced practice nursing
- 4 education program submitted by Notre Dame of Maryland University
- 5 to begin in the Fall of 2022.
- 6 You have in your attachment information, Attachment
- 7 A, the adult gerontology primary care program with all the
- 8 approvals, as well as in Attachment B, the information for the
- 9 family nurse practitioner program, and the description of the
- 10 courses.

- 2 the BSN nursing education program. The information included in
- 3 the proposal in front of you, which is effective now by the new
- 4 program of study for the entry level to the BSN program. The
- 5 curriculum will be organized in the context of the AACN's, which
- 6 include wellness, health, and the prevention in disease
- 7 management, degeneration and restorative care, special
- 8 population, and transmission to practice in leadership. For the
- 9 Board's information, the BSN curriculum remained credit neutral
- 10 with 120 credits. The course descriptions are included and they
- 11 meet the COMAR 10.27.03.13 under Curriculum Requirements, and
- 12 the general education requirements are included and specify the
- 13 professional standards for the program. This information was
- 14 reviewed by the Practice and Education Committee and approved
- 15 June 10th of 2022.
- Our recommendation today is that it's really,
- 17 first of all, depending upon the final approval authorized by
- 18 the Maryland Higher Education Commission and as MHEC approval
- 19 that the UBM staff will request that the Board accept the
- 20 recommendation from the Practice and Education Committee to
- 21 approve the University of Maryland baccalaureate curriculum

- 1 substantial modification in accordance with COMAR 10.27.03.13,
- 2 and will provide a follow-up the staff will provide a
- 3 follow-up summary to the Board.
- 4 The information included in the packet is the

- 6 Commission, the appendix on entry-level new program of study and
- 7 course description as well as the general ed content information

- 7 Historical public information is included in this
- 8 packet. There was some legal issues regarding the operation of
- 9 this program that were discovered during the review. This was a
- 10 private for-profit college system all over The United States,
- 11 and there was some major concerns about fraudulent advertising
- 12 and recruitment of students in the program that are included in
- 13 the document that you have. Then also, the third bullet
- 14 indicates the Department of Justice notice
- 15 for-profit college companies and the settlement of consumer
- 16 fraud that they had been identified with (indiscernible)
- 17 recognition of accrediting agencies of which Brown Mackie
- 18 College was a member.
- 19 We presented to the Practice and Education Committee
- 20 on June 10th of 2022, and they accepted our findings and
- 21 determination that this program is not substantially equivalent,

- 3 The next is House Bill 218: Health Occupations
- 4 Nursing Dialysis Technicians. This bill establishes a separate
- 5 category of certified dialysis technicians. Repeals the
- 6 requirement that a dialysis technician also be certified as a
- 7 certified nursing assistant except under certain circumstances.
- 8 Alters the composition of the Certified Nursing Assistant
- 9 Advisory Committee. And finally, this bill authorizes the
- 10 Board to conduct site visits of certified dialysis technician
- 11 training programs.
- 12 The Board submitted a Letter of Support with
- 13 Amendments.
- House Bill 219, cross-filed with Senate Bill 306:
- 15 Dental Hygienists Consultation Requirements Health Care
- 16 Practitioners. This bill alters the types of health care
- 17 practitioners a dental hygienist must consult with before
- 18 providing certain treatment to a dental patient. It requires
- 19 that a dental hygienist consult with a practitioner if there is
- 20 a change in the patient's medical condition.

- 7 The Board submitted a Letter of Support with
- 8 Amendments for the House Bill, and submitted a Letter of
- 9 Opposition for the Senate Bill.
- House Bill 669, cross-filed with Senate Bill 503:
- 11 Maryland Medical Assistance Program Doula Services Coverage.
- 12 This bill requires a provider to meet certain requirements in
- 13 order to provide doula services. It requires the Maryland
- 14 Medical Assistance Program to cover doula services.
- The Board took no position.
- And finally, House Bill 1208: Health Occupations
- 17 Healthcare Workforce Expansion. The bill establishes
- 18 requirements for the Board related to the expansion of the
