## ORDER LIFTING SUSPENSION AND REINSTATING CERTIFIED NURSING ASSISTANT/GERIATRIC NURSING ASSISTANT CERTIFICATE

On or about May 14, 2020, the Maryland Board of Nursing (the "Board") issued a "Final Order of Suspension of Certified Nursing Assistant Certificate for Delinquent Child Support" ("Order of Suspension"), suspending the certified nursing assistant/geriatric nursing assistant certificate "CAN/GNA" of **DWAYNE HENDERSON LANGHORN**, certificate number **A00126373** (the "Respondent").
