ORDER OF DENIAL OF REINSTATEMENT OF REGISTERED NURSE LICENSE

I. PROCEDURAL BACKGROUND

On April 24, 2012, the Maryland Board of Nursing (the "Board") accepted the voluntary surrender of the license of Charles Corey Mallory (the "Respondent") to practice as a registered nurse ("RN"), license number R177113, in the State of Maryland for a minimum of one (1) year. The voluntary surrender of the Respondent's RN license was based on the Respondent's expulsion from the Board's Rehabilitation Program.

On or about March 6, 2020, the Respondent submitted a request to the Board to reinstate his license to practice as an RN to inactive status for the purpose of completing a Board-approved nurse refresher course. On February 24, 2021, the Board granted the Respondent's request and reinstated his RN license to inactive status for purposes of completing a Board-approved nurse refresher course within one year.

II. CONSIDERATION OF REINSTATEMENT REQUEST

On or about September 5, 2021, the Respondent submitted a written request to the Board seeking reinstatement of his license to practice as an RN in the State of Maryland. In support of his reinstatement request, the Respondent provided a letter requesting reinstatement, personal and

professional letters of reference, and evidence of completion of a Board-approved nurse refresher course.

The Board has reviewed and considered all information that the Respondent submitted in support of his application for reinstatement of his RN license, as well as all additional information in the Respondent's file. Based upon consideration of the Respondent's complete file, the Board finds that additional time is needed for the Respondent to demonstrate that he is a suitable candidate for reinstatement of his RN license. Therefore, the Board finds that the Respondent has not met his burden of showing that he is a suitable candidate for reinstatement of his RN license to active status at this time. As a prerequisite to any future consideration of a reinstatement request from the Respondent by the Board, the Respondent shall submit at least six (6) months of negative drug screens.

III. ORDER

Based upon the foregoing, it is hereby:

ORDERED that Charles Corey Mallory's request for reinstatement of his registered nurse license, license number R177113, to active status is hereby **DENIED**; and it is further

ORDERED that this Order is a **PUBLIC RECORD** pursuant to Md. Code Ann., Gen. Prov. §§ 4-101 *et seq.* (2014 Repl. Vol.).
